MSC World Europa 於2022年加入地中海郵輪船隊，成為地中海郵輪有史以來最大型的郵輪！MSC World Europa的總噸位達205,700噸，可容納6,774位乘客，擁有21層甲板。

MSC World Europa 將有一個僅限成人使用的“**禪區Zen Zone**”和一個“**家庭區Family Zone**”，其中容納多個兒童設施，適合一家大細享受天倫之樂。船上還設有娛樂場所、商店和酒吧集中在中央室內長廊，長廊長295 ft，一半向天空開放，一半被LED天幕覆蓋。MSC World Europa 的其中一個全新設計**The Venom Drop @ The Spiral**，一條位於頂部的滑道，客人可穿梭11層甲板滑向座落於中央室內的長廊之中！
