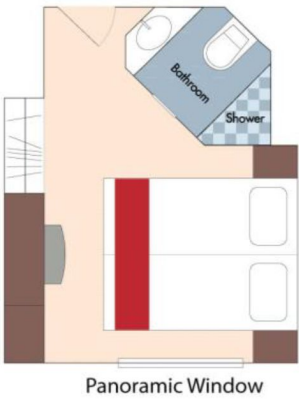

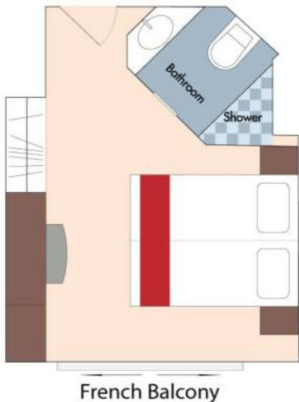

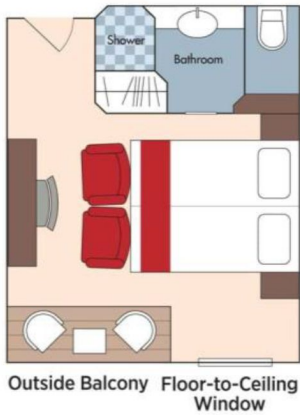
Panoramic Window
